BOOKING TERMS & CONDITIONS

1. All tickets, vouchers and other documents relating to transport, accommodations or other services and facilities (hereinafter referred to as "the travel services") are issued by or on behalf of Morris Negroto, S.A. (hereinafter referred to as "the company") only as agents for each of the concerns with whom the company may have arrangements for its clients (hereinafter referred to as "the principals") and are issued subject to these terms and conditions and those of the principals.

2. We always do our best to make our clients' travel arrangements but only you as a client are responsible for the safety of the activities you engage in. We do not assume any liability for injury, death, loss of property or damage to goods or loss of money or other property.

3. Except in the event of a medical emergency, you will receive no refund if you cancel your booking more than 30 days before departure. If you cancel your booking less than 30 days before departure, you will be given a credit towards a future stay.

4. Any cancellation made by a client must be received in writing. The following cancellation fees apply:
a. If the written cancellation is received by the company not later than 90 days prior to departure, the complete deposit is non-refundable.
b. If the written cancellation is received by the company not later than 60 days prior to departure, the complete deposit is non-refundable.
c. If the written cancellation is received by the company not later than 30 days prior to departure, the complete deposit is non-refundable.

5. The company shall not be liable in the event, due to climatic conditions, that satisfactory surf is unavailable that surf is of too great a magnitude for a client to partake in such activities. The passengers shall comply with the instructions of the principals at all times. No passengers shall remain on a boat while their status of mental or physical condition is, in the opinion of the principal, such as to render them incapable of caring for themselves or others.

6. If any passenger makes themselves or others a hazard to the passengers and the company will not be responsible for expenses by such persons during the tour for these reasons.

7. Passengers are strongly advised to cover loss of baggage, personal effects, and medical insurance will also cover monetary loss of property beyond your contribution. Passengers are advised to make travel insurance.

8. The principals have the right to cancel or modify the tour or to change the itinerary as may be found necessary due to weather conditions or otherwise of climatic conditions. The company shall not be responsible for any additional personal expenses incurred by the passengers, including delay from the tour. It will be the responsibility of the passengers to make their own arrangements for services not included. This is for their benefit.
