- All tickets, vouchers and other documents relating to transport, accommodations or other services and facilities (hereinafter referred to as "the travel services") are issued by or on behalf of SURFER PARADISE (hereinafter referred to as "the company") only as agents for each of the concerns with whom the company may have arrangements for its clients (hereinafter referred to as "the principals") and are issued subject to the terms and conditions and those of the principals.
- We always do our best to make such arrangements as satisfactory and we do not accept any liability for any loss or damage to you as a result of our gross negligence or the negligence of our employees. However, we cannot accept liability of the acts, omissions or defaults, whether or not caused by the negligence of those principals providing services with your holiday pursuant to a contract entered into by you and yourself (which may be evidenced by a ticket, voucher, coupon or receipt) or of whom we have no direct or exclusive control. We do not accept any liability in contract for injury, damage, loss, delay, additional expense or inconvenience caused directly or indirectly by the acts, omissions or defaults of those principals or other events which are beyond our control, including but not limited to war, civil disturbances, floods, unusually severe weather, acts of God, acts of Government or any authorities, accidents, theft, loss of machinery or equipment.
- Except where otherwise stated, a deposit is due within 7 days of booking confirmation. The balance of the total cost is due upon arrival in Panama City. (or such later date as shall be specified in writing by the company).
